Tender Notice

Procurement of Reactor Separator S-36101 M1 for TDI II Dahej Plant.

GNFC intends to procure "**Reactor Separator S-36101**" for its TDI II plant situated at Dahej.

Important instructions to the bidders:

- 1) The Tender documents (Ref No. **MM/MMD/10093908**) for this requirement are available on our website www.gnfc.in under the Section: Tenders (<http://www.gnfc.in/tenders.html>)
- 2) The intending bidders must comply to the below stated "Eligibility Criteria".

ELIGIBILITY CRITERIA:

- a) The bidder shall be Manufacturer of Pressure Vessels / Columns and have experience for manufacturing of Volume 100 M³ with Design Pressure of 10 Bar g, minimum 15 nos. of such equipments and must have supplied same to any one of the hydrocarbon sector like Refineries/Petrochemicals/ Fertilizers/ Oil & Gas processing plants .
- b) The bidder must have supplied Pressure vessels / Columns of exotic material like Inconel 600 / Inconel 625/ Inconel 800/ Hastelloy C-276 / Super Duplex /Duplex & also manufactured from any one of such exotic material stated here having minimum diameter 3500 mm and 8 meters height of single equipment.
- c) Bidder must have executed minimum 10 nos. of orders under Third party inspection of M/s Lloyd's Register/ M/s Bureau Veritas/ M/s SGS.
- d) Bidder's last three year minimum average turnover must be Rs: 300.00 lakhs/year and a single order of value not less than Rs. 200.00 lakhs in any of previous three years period ending last day of the month previous to the one in which tender is invited.
- e) The bidder shall not be in the Holiday/ Blacklist/ of any CPSU/ State PSU/ Central or State Government Undertaking.
- f) Net worth during the last audited financial year must be positive.
- g) Consortium / joint bids shall not be accepted.

- 3) The bidders are required to submit the offers to GNFC in two separate sealed envelopes as under.
- A. **1st envelope** with subject line "**TECHNICAL BID – MM/MMD/10093908**" shall be sent along with following documents:
- (a) Confirmation on Eligibility Criteria – Annexure A.
 - (b) Supporting documents as mentioned in Eligibility Criteria.
 - (c) Bidder's technical offer along with un-priced copy of price bid.
 - (d) All technical documents (drawings / annexures) dually signed and stamped as a token of unconditional acceptance.
 - (e) Annexure-X2 / Annexure –I dually filled with all details – as per applicability.
 - (f) GNFC's General Conditions of Purchase (GCP) dually signed and stamped of acceptance.
 - (g) Deviation Sheet – dually filled with deviations, if any.
- B. **2nd envelope** with subject line "**PRICE BID – MM/MMD/10093908**" shall be sent containing price bid for the items quoted, based on the technical bid submitted by the bidder.
- 4) **Tender Rejection Criteria (TRC) :**
1. The bids received from bidders who are not complying to "Eligibility Criteria" will not qualify for evaluation.
 2. Bids received after the due date and time of bid submission.
 3. Non adherence to technical/commercial terms, incomplete bids, bids in deviations to tender conditions, bids with falsified or incorrect information, bids not conforming to Un-price / Price Bid format, manipulated or unsigned bids.
 4. If price bid is submitted along with technical bid.
 5. Bids received without quote for spares of respective exchanger will be rejected.
- 5) Submission of false, dubious, forged or tampered information or documents by the intending participant/Bidders/Suppliers shall lead to the disqualification of the Bid / termination of the contract and action, including but not restricted to damages for breach of contract and procurement of ordered quantity from the market at the risk and cost of the Supplier, shall be taken by the Company.
