Procurement of (i) **M.S. welded barrels & (ii) M.S. un-welded barrels with seaming compound thro'** (n)Code Solutions by e-Tender

Gujarat Narmada Valley Fertilizers & Chemicals Ltd., Bharuch (GNFC) is a joint Sector Company Controlled by Govt. of Gujarat. GNFC is in the business of manufacturing Fertilizers, Chemicals, Petrochemicals and Industrial products as well as providing IT/ITES services. You can visit our website www.gnfc.in for more information about our company.

GNFC procures MS welded barrels under Annual Rate Contracts (ARCs) with price variation clause based on ESSAR grade: CR2-IS 513 D rate. GNFC intends to invite bids through e-Tender on (n)Code Solutions platform for finalization of ARCs for procurement of their annual requirement of (i) about 2.12 lakh of MS welded of 22 Kg to fill TDI/Aniline/OTD/MTD (ii) 0.53 lakh Un-welded barrels of 19 KG, to fill TDI; for Bharuch & Dahej plant (For Bharuch plant : 68,300 Nos. welded barrels & 17,000 Nos. un-welded barrels with seaming compound; For Dahej plant : 1,44,000 Nos. welded barrels & 36,000 Nos. un-welded barrels with seaming compound) during the period from 01.06.2019 to 31.05.2020.

The technical specifications of these M.S. welded barrels & Un-welded barrels with seaming compound are available on our website www.gnfc.in under the Section: "Materials Management > Major Categories of Items Purchased by GNFC > Packaging items (M.S. welded barrels & un-welded barrels with seaming compound)

The e-Tenders for aforesaid requirement of (i) M.S. welded and (ii) un-welded barrels have been published on 01.04.2019 on (n)Code Solutions portal, with due date for bid submission on 09.04.2019, 15 hr.

The GNFC approved vendors will be required to ensure that they are registered with (n)Code Solutions to participate in this e-tender for the aforesaid requirement of M.S. welded & un-welded barrels.

The intending participants who are not an approved vendors of GNFC and complying the below stated "Eligibility Criteria", will be required to submit the application to GNFC attaching

the required documents mentioned hereunder, and obtain the confirmation on pre-qualification for participation in the e-Tender, from GNFC.

The pre-qualified vendors would be eligible for participating in the e-Tender subject to registration with (n)Code Solutions.

ELIGIBILITY CRITERIA:

- 1) The intending participant must have plant/facility for manufacturing of M.S. welded barrels OR un-welded barrels in India. The annual capacity of the said plant/facility must be at least one and half times the quantity of M.S. welded barrels and/or un-welded barrels offered for sale and supply to the Company.
- 2) The intending participant must have been engaged in the business of manufacture, sale and supply of M.S. welded barrels and/or un-welded barrels for a minimum of 02 (two) years prior to the date of commencement of rate contract period.
- 3) The manufacturer must possess valid and subsisting permissions and licenses for manufacture, storage, handling and sale of M.S. welded barrels and/or un-welded barrels issued by authorized agency / authority.
- 4) Net Worth during the last audited financial years shall be positive.
- 5) The vendors de-listed by GNFC shall not be considered for pre-qualification till their re-enlistment.
- 6) The Vendor / bidder blacklisted by any Central / State Govt. / PSUs or Local Govt. Deptt. / Autonomous Body, as on the date of application and debarred from participation in the tender process, will not be qualified for participation in the e-Tender.
- 7) The Proprietor/Partner of the sole proprietary firm/partnership having criminal cases pending against them (except cases under the Negotiable Instruments Act., 1881) as well as a Company, having criminal case, other than one under Negotiable Instruments Act, 1881, filed against the Company, will not be qualified for participation in e-Tender.

DOCUMENTS TO BE SUBMITTED FOR PRE-QULIFICATION:

1.0 A Certificate (self certified & stamped) stating that the intending participant has plant/facility for manufacturing of M.S. welded barrels and/or un-welded barrels in India and has annual manufacturing capacity of the said plant/facility at least one and half times the

quantity of M.S. welded barrels and/or un-welded barrels offered for sale and supply to the Company.

The certificate should specify the installed manufacturing capacity for M.S. welded barrels and/or un-welded barrels.

2.0 Experience Certificate(s) showing proven experience in manufacturing of M.S. welded barrels and/or un-welded barrels for a period of at least 02 (Two) years. (Self certified copies of Purchase orders for the last two years to be furnished).

3.0 A certificate stating that the manufacturers possess valid and subsisting permissions and licenses for manufacture, storage, handling and sale of M.S. welded barrels and/or un-welded barrels issued by authorized agency / authority.

4.0 A certificate from the bankers about financial status and credibility showing the solvency position of the bidder. (Solvency up to Rs. 50 lacs and date of issue should not be more than three month old.).

5.0 Duly audited balance sheet and Profit/Loss account of preceding TWO financial year showing annual gross turnover of the Company duly certified by a Chartered Accountancy firm.

6.0 Certified copy of Income Tax returns (Last one Financial Year) filed by the bidder.

7.0 Constitution of the firm, if the bidder is not a sole proprietary concern; for partnership firm a partnership deed; for a registered company it's Memorandum of Association and Articles of association; and for a co-operative society its registration certificate.

8.0 Certified Copy of PAN

9.0 Copies of Goods & Service Tax (GST) Registration and Explosive license (whichever applicable or at the discretion of the Company).

10.0 Self certificate stating that the bidder is not blacklisted by any Central / State Govt. / PSUs or Local Govt. Dept. / Autonomous Body, as on the date of application and is not debarred from participation in the tender process.

11.0 A self certificate of the Proprietor/Partner of the sole proprietary firm/partnership stating that no criminal cases are pending against them (except cases under the Negotiable

Instruments Act., 1881). In case of a Company, a certificate signed by the Company Secretary confirming that no criminal case, other than one under Negotiable Instruments Act, 1881, has been filed against the Company.

Note:

Submission of false, dubious, forged or tampered information or documents by the intending participant/Bidders/Suppliers shall lead to the disqualification of the Bid / termination of the contract and action, including but not restricted to damages for breach of contract and procurement of ordered quantity from the market at the risk and cost of the Supplier, shall be taken by the Company.

GENERAL INSTRUCTIONS:

1) The intending participant should be an approved vendor of GNFC for supply of M.S. welded barrels and/or un-welded barrels or must have at least applied for enlistment as an approved vendor for supply of M.S. welded barrels and/or un-welded barrels with the Company. The procedure apply online to become GNFC approved vendor is stipulated at Appendix – A.

2) The eligible manufacturer, in order to participate in the e-Tender to be conducted by (n)Code Solutions, must also obtain registration with (n)Code Solutions. For information and/or clarification about registration with (n)Code Solutions, the vendor may contact (n)Code Solutions.

3) The intending participant who is not an approved Vendor will be required to submit the application with above documents, complete in all respects in “secured pdf” format **within 3 days** from the date of issuance of the e-Tender, by email to GNFC Ltd. as under:

4) The Application received after above stated date or incomplete applications for any reason whatsoever may not be considered. Furnishing false/incomplete information or submitting applications not accompanied by required documents shall lead to summarily rejection of the application.

5) In case any vendor(s) other than existing approved vendors win the bid by becoming L-1 or by matching rate of L-1 bid, they will initially make 2-3 trial supplies each of about 200 nos. of welded and/or un-welded barrels to GNFC and get approval from GNFC. In parallel, such new parties will have to apply online for approval of GNFC as an approved vendor. GNFC at its discretion may restrict allocation to such a new vendor qualifying for order, as compared to the other existing approved vendors.

6) GNFC reserves the right to reject any or all the applications or withdraw this invitation without assigning any reason thereof. Decision of GNFC in the matter shall be final and no correspondence shall be entertained from the applicants subsequently. GNFC has the liberty to include or delete vendors based on their performance, proven capability and for any other reason thereof.

Appendix –A

The procedure to become GNFC approved vendor is as follows:

1. The M.S. welded barrels and/or un-welded barrels manufacturer who desires to get registered with GNFC has to submit online application available on GNFC website www.gnfc.in for vendor registration.
2. The application will be evaluated by GNFC Vendor Evaluation Committee (VEC).
3. If the applicant is found potential by VEC, based on recommendation of VEC, shop evaluation visit is being carried out by GNFC team.
4. Based on report of Team, proposal is being put up to Vendor Registration Steering Committee (VRSC) for approval for considering party and for trial orders.
5. On approval of VRSC, 2/3 trial orders are being issued on the party for establishing sustainable quality supply of M.S. welded barrels and/or un-welded barrels.
6. On successful execution of trial orders, party is being added in the GNFC approved vendor list for supply of M.S. welded barrels and/or un-welded barrels.
